EU FINALIZES LANDMARK AI LEGISLATION: A GLOBAL FIRST

The European Union has set a global precedent by finalizing a comprehensive framework to regulate artificial intelligence (AI). This landmark legislation adopts a risk-based approach, focusing on high-risk and general-purpose AIs. It prohibits certain AI applications, like biometric categorization and untargeted facial recognition scraping, and imposes strict limits on law enforcement's use of remote biometric identification, requiring judicial approval in specific cases. Excluding military applications and non-professional AI use, this legislation aims to ensure a balance between innovation, fundamental rights, and European values, with enforcement starting as early as 2026.

UK INVESTIGATES MICROSOFT/OPENAI PARTERNSHIP

The UK's Competition and Markets Authority (CMA) is investigating the relationship between Microsoft and OpenAl. This scrutiny follows concerns about a potential "relevant merger situation" after Microsoft gained a board seat in OpenAl. The investigation focuses on the implications of their collaboration for competition in the Al market.

SOUTHWEST AIRLINES FLIGHT ATTENDANTS REJECT CONTRACT AGREEMENT

Flight attendants at Southwest Airlines, represented by the Transport Workers Union Local 556, have overwhelmingly rejected a proposed contract agreement. The decision, made by a 64% to 36% vote, reflects the union's stance to stand united for better outcomes. Despite the rejection, holiday travel will not be impacted. Southwest Airlines, expressing disappointment, will continue to operate under the current contract while awaiting further actions from the National Mediation Board and union.

BAR DIGEST: WHAT HAVE YOU MISSED?

- 1. Family Legal Aid Extended
- 2. New Law Forces Offenders to Attend Sentencing Hearings

FAMILY LEGAL AID EXTENDED

The eligibility of legal aid for private family law cases has been made more extensive. The reform surrounds Special Guardian Orders (SGOs) which are court orders in the UK that appoint one or more individuals as guardians for a child. They are made when a child cannot live with their birth parents but need long-term placement; and when granted, they allow those with parental responsibility to make legal decisions for the child. The broadened scope of family law legal aid now includes:

a. prospective guardians making applications for Special Guardianship Ordersb. and anyone with parental responsibilities responding to Special Guardianship Orders made by others.

The privilege of legal aid has been extended to private family law, this means the welfare of the child can now be freely safeguarded in matters like divorce, inheritance disagreements, and division of assets. The changes made in May 2023 bring the financial eligibility requirement in line with cases covered by public family law.

NEW JUDGE DISCRETION - FORCED ATTENDANCE AT HEARINGS

In the aftermath of the Lucy Letby hearing, where the notorious child serial killer refused to attend her own hearing, the Ministry of Justice is wielding new powers. Judges will now have the discretion to compel offenders to attend their sentencing, making it "clear in law" that reasonable force ccan be used. This move, however, faces spirited debates, with Silks (King's Council barristers) such as Kat Bex KC, questioning its validity. The crux of the controversy is that the order will only apply where maximum sentences are involved, with a potential two-year jail time extension for non-compliance. Critics recognise that this small increase tacked on to a life sentence is ineffective and performative. On the flip side, there is concern that brining taunting offenders to court and allowing them to mock the proceedings may do more harm then good - particularly on amplifying victims' distress.

Supporters contend that the threat of additional prosecution and the judicious use of force could dissuade all but the most resolute criminals from evading public accountability. PM Rishi Sunak asserts, "People rightly expect criminals to face up to the consequences of their actions."

The looming question: Is this legislative shift purely for show, or does it genuinely address systemic issues in our criminal justice system? Can forcing offender attendance bring the closure victims seek? And, crucially, can we trust custody officers to exercise "reasonable force"? As these inquiries linger, we invite our readers to weigh in on the discourse.
